Berlin, a city that overcame the conflicts of the Cold War and that became a symbol of peace and integration in Europe, is a highly symbolic place for fostering dialogue and exchange of ideas concerning the past, present and future of the Korean peninsula. The Korea Europe Review answers to the growing demand for scholarly expertise in the multi-disciplinary, comparative, social science-oriented study of the Korean peninsula and its near neighbour's, but also, in a methodological sense, to the need to transcend traditional, disciplinary confines of regional and area studies in order to integrate scholarship on the Korea peninsula in just such multidimensional contexts. KER aims to reflect the region's increasing importance in terms of geo-cultural and geo-economic dynamics. This pertains to developments of old and new forms of political, cultural, social and economic hegemony in East and South-East Asia, both on a theoretical-conceptional level as well as in terms of concrete phenomena of transregional, international and indeed global power structures. The critical assessment of these dynamics and their diverse impact on the Korean peninsula but also on the larger, indeed international context of cultural and economic networks and cooperation throughout the Asia-Pacific thus form a core area of interest of this journal. It naturally also encompasses the creation of new boundaries through the appropriation, translation and reconfiguration of linguistic, cultural and religious practices and
